1. Roll Call:

A regular meeting of the Hoffman Estates Park District Administration & Finance Committee was held on March 26, 2019 at 7:10 p.m. at the Triphahn Center in Hoffman Estates, IL.

2. Approval of Agenda:

Comm Rep Winner made a motion, seconded by President Kaplan to approve the agenda as presented. The motion carried by voice vote.

3. Approval of the Minutes:

Commissioner Bickham made a motion, seconded by Comm Rep Winner to approve the minutes of the February 26, 2019 meeting as presented. The motion carried by voice vote.

6. New Business:

A. A&F Report/M19-035:

Director Hopkins reviewed the report noting that staff had been busy preparing for the auditors who had completed their field work last week. She noted all went smoothly and would expect the audit to be completed in the coming months.

She also explained that Accounting Manager Meschewski had done an excellent job setting up the Star and Kinder Star programs for online registration. She noted that the new computers had arrived and were being deployed.

Comm Rep Winner asked about the preschool lottery and Director Kapusinski noted that everyone was placed in a class, but not everyone received their first choice. Comm Rep Winner also asked about the new computers and Executive Director Talsma explained that they were replaced on a rotation basis.

Comm Rep Winner made a motion, seconded by President Kaplan to send the A&F Report M19-035 to the board. The motion carried by voice vote.

B. Open and Paid Invoice Register:

Director Hopkins reviewed the items. Chairman Kilbridge asked about the \$50 fee for Embryo Training Packets and Director Kapusinski noted that the preschool was working with chicks.

President Kaplan asked about the Chair Tech LLC charges and Executive Director Talsma explained that the district had also purchased office chairs in addition to the board room chairs.

Chairman Kilbridge asked about the American Express credit and Director Hopkins explained that there had been a fraudulent charge last month that had been credited.

Comm Rep Winner made a motion, seconded by Commissioner Bickham to recommend the board approve the Open and Paid Invoice Register in the amount of \$516,429.87. The motion carried by voice vote.

C. Revenue and Expenditure Report:

Director Hopkins reviewed the information noting that the district was \$391,000 behind in receipt of property tax but it was a matter of timing. She also noted that

timing explained the variances seen in other line items and the variance in the payroll would be addressed next month.

She also noted that the Star program and ELC were ahead of prior years and that the hockey rental was behind due to the loss of the men's hockey rental to Mount Prospect.

Commissioner Bickham made a motion, seconded by President Kaplan to recommend the board approve the Revenue and Expenditure as presented. The motion carried by voice vote.

7. Committee Member:

Commissioner Bickham noted that the fish fry was excellent and he was glad to see the district offering family bingo.

Comm Rep Winner said the fish fry was great and wished all candidates good luck in the election.

Chairman Kilbridge thanked staff for the excellent reports.

DATE: April 17, 2019

Background:

The park board has previously awarded supply of equipment for playground improvements at Willow and Community Parks. With those purchase orders being issued, staff prepared bid documents for the installation of that equipment and associated work consisting of removal of fall surface, installation of new equipment, drainage and fall surface systems and new concrete where necessary. In addition to the playground work at these two sites, some concrete replacement work at Community Park was included in this package, specifically a concrete walkway to the new splash pad to move away from the street location.

Implications:

Seven bids were received for these projects and read aloud and attached is a summary of the bids received.

The low bid from George's Landscaping was reviewed by staff for accuracy and completeness, and all numbers were confirmed by bidder. George's Landscaping completed the installation of Valley, Maple and Evergreen Parks for the district in 2015. The district was pleased with the quality of work and timelines were all met in 2015. Staff also contacted Homewood-Flossmoor Park District, Tinley Park Park District and Fox Valley Park District which had similar jobs started and completed in 2018 by George's Landscaping. They were pleased with the work and timelines were met.

Recommendation:

Staff recommends that the A&F Committee recommend that the Board approve a contract with George's Landscaping for the installation of playground equipment at Willow and Community Parks for the low bid price of \$114,005.50.

In addition, staff recommends the A&F Committee recommend the Board approve a contingency of 5% (\$5,700) be made available for extras deemed necessary by staff to complete these projects.

A. Finance/Administration

- Lauterbach & Amen completed their on-site field work and testing. The process was smooth and efficient similar to last year. Staff anticipates the audit in draft form being presented at the May meeting.
- IMRF has changed their assumed rate of return on their investment portfolio from 7.5% to 7.25% to better reflect the actual return and outlook. Our preliminary rate for IMRF in 2020 is 7.39% versus our current rate of 5.10%. The average contribution rate for all members is between 10.15% and 10.65%. The increase in rate is due to the under performance of their investment portfolio. The District had the opportunity to amortize the increase over 10 years but determined that the one time increase was the better option. The current shortfall will result in a liability of over \$1.7 million reported in our audited financial statements.
- Applicable quarterly 941 wage reports were filed at the federal and state levels.
- Staff has begun preparing for the TC/WRC pass conversion.
- Several staff attended the BSA user group meeting.
- Staff attended IAPD/IPRA Exhibit Committee post conference meeting.
- Staff worked with BPC staff to ensure Bev Carts were ready to go with new credit card processing technology.
