**MINUTES  
ADMINISTRATION AND FINANCE COMMITTEE  
July 23, 2019**

**1. Roll Call:**

A regular meeting of the Hoffman Estates Park District Administration & Finance Committee was held on July 23, 2019 at 7:10 p.m. at the Triphahn Center in Hoffman Estates, IL.

Present: Chairman McGinn, Commissioner Kilbridge, Comm Reps Kulkarni, Winner

Absent: Comm Reps Musial, Utas, Wilson

Also Present: Executive Director Talsma, Director of Finance and Administration Hopkins, Director of Recreation Kapusinski, Director of Parks, Planning and Maintenance Hugen, Director of Golf and Facilities Bechtold

Audience: Commissioners Chhatwani, K. Evans, Kinnane

**2. Approval of Agenda:**

Comm Rep Winner made a motion, seconded by Comm Rep Kulkarni to approve the agenda as presented. The motion carried by voice vote.

**3. Approval of the Minutes:**

Comm Rep Kilbridge made a motion, seconded by Comm Rep Winner to approve the minutes of the June 25, 2019 meeting as presented. The motion carried by voice vote.

6. **New Business:**

A. **Rink 1 Ice Project Change Order/M19-075:**

Director Hugen reviewed the item noting that the change order had been not to exceed \$175,000 and approved by both the B&G Committee and the Board via email. He noted that the change order was to change the structural concrete to avoid settlement issues. Commissioner K. Evans asked about mud jacking and it was noted that the engineer said it would give the same flooring, but not be structural. The exact change order amount was \$168,934. Commissioner K. Evans asked if that included a contingency and Director Hugen noted that it did not.

Commissioner Kinnane asked if there might be anything still down the road not yet identified that we would need a contingency for as they had \$10,000 left of the original contingency fund. Director Hugen noted the only other work would be to drop in a sump pump but staff would not know until the perimeter drainage was put in and that it could possibly be done internally. Director Hugen noted that he felt the rink would be good for the next 30 years.

Executive Director Talsma distributed a time line and asked for an update. Director Hugen noted that Minnesota Ice had worked until June 28<sup>th</sup> with the installation of new main lines from June 24 through the 28<sup>th</sup>. He explained that all concrete and gravel was removed and water was found. Stantec provided reports by July 2<sup>nd</sup> which was turned around by July 12. He noted the structural engineer was involved to determine the best way to solve the concrete issue (costing the district 10 days). The information provided was reviewed by the board and when the \$175,000 change order was approved, staff went back to Minnesota Ice. Minnesota Ice was presently working with subcontractors to remove and pour new concrete with concrete work scheduled to begin July 29<sup>th</sup>. This would add two weeks to the project schedule. The original plan was now delayed by 7 weeks and the district would be looking at an October 25<sup>th</sup> completion date with the ice ready by November 1, 2019.

Director Hugen noted that staff had been pushing and that Minnesota Ice and Stantec had said that “due to soil conditions and mud slab affected, they needed to look into every angle to make sure the district was building the proper rink”.

Commissioner Kinnane asked if Minnesota Ice had other projects on the book and if they would be dedicated to our project. Director Hugen noted that they were willing to pull staff from other projects to complete this one.

Commissioner Kilbridge asked for an explanation of who Minnesota Ice, Stantec and the subcontractors were. Director Huguen explained that Stantec was the consultant, Minnesota Ice had won the bid and was doing all the mechanical and that the two subcontractors were for concrete removal and installation and the dasher boards.

Comm Rep Winner asked if they would risk cutting corners by trying to expedite the project and Director Huguen noted that they were not cutting corners; that they were less worried about the September 6<sup>th</sup> deadline and more about the next 30 years.

Chairman McGinn asked about leaving \$175,000 available in case of future contingencies and Commissioner Kilbridge asked about the impact on hockey. Executive Director Talsma explained that it would affect rentals.

Commissioner Kinnane asked about the impact to the Wolves at this time and Director Talsma noted that they used ice when school is in session plus two weekend hours.

Comm Rep Kulkarni made a motion, seconded by Comm Rep Winner to recommend the board approve a change order in the amount not to exceed \$175,000 to Minnesota Ice to continue with the Ice Rink project. The motion carried by voice vote.

B. A&F Report and 2Q Goals/M19-071:

Director Hopkins reviewed the report noting that the financial advisor agreement with Barclays to refinance the district bonds by August 8<sup>th</sup> for a projected savings of \$750,000. She also noted that they had started the process of scanning member documents into Rectrac Households giving staff access to the documents and that they would go back to the beginning of the year.

Executive Director Talsma noted that the district had found out a day earlier that the Wolves would not renew their contract. He noted that there was very little communication between them. They requested to leave 30 days after the end of their season and it was unknown where they would be going.

Chairman McGinn noted that he appreciated the commentary on the funds and like that the scanning was going back to January. He asked if the district had received and FOIA requests and Director Hopkins noted that they FOIA requests were consistent with other requests.

Comm Rep Winner asked about attending a minimum of 12 community events and if that was an annual or monthly goal. Director Hopkins noted that it was the Adv & Sponsorship Manager's annual goal.

Comm Rep Winner made a motion, seconded by Commissioner Kilbridge to send the A&F Report and 2Q Goals M19-071 to the board as presented. The motion carried by voice vote.

C. Open and Paid Invoices:

Commissioner Kilbridge asked about the Amazon charges and if there was a way to cut back so there was not so much waste through the packaging. Director Hopkins noted that even if it was not Amazon, the packaging would most likely be the same.

Commissioner K. Evans noted that by buying local, they were supporting the tax payers. Executive Director Talsma noted that most online sales would begin charging tax by the end of the year.

Chairman McGinn asked about the CDW \$18,000 Microsoft upgrade and Executive Director Talsma noted that it was a license renewal. Chairman McGinn asked why Microsoft was not the seller and Executive Director Talsma noted that CDW was the authorized seller and that the district licenses each computer.

Commissioner Kilbridge asked if it was a yearly charge and Director Hopkins explained that IT Manager Agudelo had just made the deadline and the next upgrade would force the district into 365 subscription service which would be more expensive. He was looking to going eventually to the cloud.

Comm Rep Winner asked how many users the district had and Executive Director Talsma noted it was at least 80.

Comm Rep Kulkarni asked if CDW or a 3<sup>rd</sup> party would do the install and Executive Director Talsma noted that the IT department of 2 handled all upgrades but that if needed, they did have a third party, Sterling, that could be called upon.

Comm Rep Winner made a motion, seconded by Comm Rep Kilbridge to recommend the board approve the Open and Paid Invoice Register in the amount of \$703,912.79. The motion carried by voice vote.

D. Revenue and Expenditure Report:

Director Hopkins reviewed the issue noting that the investment income was higher than prior years. She noted that the General Fund was over budget due to a delay in the South Ridge Project and an increase in property taxes. She noted the Rec Fund C&M postage consistent with prior years but would be over budget and that Aquatics was down from prior years as June was so cool and wet. She went on to review the Ice noting that “Try figure Skating for free” had brought higher enrollment and youth hockey participation was up; EC was up \$67,000; Camp down from the prior year but the overall Rec Fund was projected to be ahead of budget. Delay on the ice could impact the year end.

Director Hopkins noted that The Club C&M was up \$14,000 by eliminating direct mail due to the limited return; that The Club was expected to be below budget by

\$175,000; Maintenance had FM & R \$21,000 over prior year due to repairs; BPC had F&B up and that revenue was \$73,000 due to larger events and expenses down without a Sous Chef. She noted that the Chef position salary was down \$27,000 due to a delay in opening from the spring weather and that BPC would be below budget by the end of the year. She noted that there could still be significant changes in the year end numbers and the projections were based upon history and patterns.

Commissioner K. Evans commended staff on the excellent summary.

Commissioner Kilbridge made a motion, seconded by Comm Rep Kulkarni to recommend the board approve the Revenue and Expenditure as presented. The motion carried by voice vote.

**7. Committee Member Comments:**

Chairman McGinn congratulated Comm Rep Kulkarni on his appointment.

Comm Rep Kulkarni thanked him for the appointment.

Comm Rep Winner also welcomed Comm Rep Kulkarni.

Commissioner Kilbridge noted that Director Hopkins reports and narratives made the financials so much easier. She also welcomed Comm Rep Kulkarni.

Chairman McGinn welcomed Commissioner Chhatwani to the Board.

**8. Adjournment:**

Comm Rep Winner made a motion, seconded by Commissioner Kilbridge to adjourn the meeting at 7:55 p.m. The motion carried by voice vote.

**Background**

The District has been in negotiations with Barclays and their representatives to do a forward purchase agreement for the Series 2010A bonds. Barclays have been involved in similar transactions since the elimination of advance refunding last year. In conjunction, the attorneys representing the bank have asked for some minor changes to the ordinance approving the bond issuance. Our bond counsel have reviewed the request and made the changes.

**Implications**

The items are clerical in nature due to the structure of the agreement and have no impact on the original intent of the ordinance.

**Recommendation**

That the A&F Committee recommend to the full board approval of Amended and Restated Ordinance No. O19-004.

AMENDED AND RESTATED ORDINANCE NO. O19-004

AN AMENDED AND RESTATED ORDINANCE PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION PARK REFUNDING BONDS (ALTERNATE REVENUE SOURCE), IN ONE OR MORE SERIES, OF THE HOFFMAN ESTATES PARK DISTRICT, COOK COUNTY, ILLINOIS, IN AN AGGREGATE AMOUNT OF \$31,000,000.

WHEREAS, the Hoffman Estates Park District, Cook County, Illinois (the “District”), is a duly organized and existing municipality operating under the provisions of the Park District Code, as amended, and under the laws of the State of Illinois; and

WHEREAS, the District has previously issued its: (i) Taxable General Obligation Bonds (Alternate Revenue Source), Series 2010A; (ii) General Obligation Bonds (Alternate Revenue Source), Series 2010B; (iii) General Obligation Bonds (Alternate Revenue Source), and Series 2010C (collectively, the “Prior Bonds”); and

WHEREAS, the Board of Park Commissioners of the District (the “Board”) has determined that it is advisable, necessary and in the best interests of the District to refund all or a portion of the Prior Bonds over the next three years when economically feasible upon market conditions and the advice of its municipal advisor, and to pay certain costs of issuance and incidental expenses, all for the benefit of the inhabitants of the District (in each instance, a “Refunding”); and

WHEREAS, each Refunding is exempt from the requirements of the Local Government Debt Reform Act of the State of Illinois (the “Act”) because the term of any refunding bonds will not exceed the term of the refunded bonds and the debt service on the refunding bonds will not exceed the debt service of the refunded bonds; and

WHEREAS, the Board is now authorized to issue alternate bonds in accordance with the provisions of the Act, and the Board hereby determines that it is necessary and desirable that bonds in one or more series and in an aggregate amount of \$31,000,000 be issued; and



WHEREAS, the revenue sources that will be continue to be pledged to the payment of the principal and interest on the alternate bonds will be (a) charges for services in the District and (b) such other funds of the District lawfully available and annually appropriated for such purpose including monies lawfully available from the issuance of the District's general obligation bonds or notes from time to time to the fullest extent permitted by law and payable from the Debt Service Extension Base (collectively, the "Pledged Revenues"); and

WHEREAS, if the above-mentioned Pledged Revenues are insufficient to pay said alternate bonds, ad valorem property taxes upon all taxable property in the District without limitation as to rate or amount are authorized to be extended to pay the principal of and interest on said alternate bonds;

WHEREAS, this ordinance amends and restates Ordinance O19-003 as adopted on June 25, 2019;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE HOFFMAN ESTATES PARK DISTRICT, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Incorporation of Recitals. The Board hereby finds that all of the recitals contained in the preambles to this ordinance are full, true and correct and do incorporate them into this ordinance by this reference.

Section 2. Issuance of Bonds. It is hereby found and determined that the Board of said District has been authorized by the provisions of the Act to issue alternate bonds of said District in one or more series and in the aggregate amount of \$31,000,000 for the purpose of paying the costs of the Refunding and costs of issuance and expenses incidental thereto, along with such other funds made available for such purpose by the District in a Bond Order (hereinafter defined), all for the benefit of the inhabitants of the District to serve the inhabitants

of the District and that such borrowing of money is necessary for the welfare of the government and affairs of the District, is a proper public purpose and is in the public interest.

There shall be borrowed on the credit of and for and on behalf of the District, the aggregate principal amount of \$31,000,000 in one or more series, taxable or tax-exempt, to implement the Refunding and the costs of issuance incidental thereto, and the District shall issue in the name of the District its “General Obligation Park Refunding Bonds (Alternate Revenue Source), Series 20\_\_ (with appropriate series designation)” (the “Bonds”) pursuant to the Act.

The Bonds shall be issued in the denomination of Five Thousand Dollars (\$5,000) each or integral multiples thereof, numbered consecutively from 1 upward, and dated the date of delivery. The Bonds shall mature or be subject to mandatory redemption over a period ending not later than December 1, 2040, and provided that for each series of bonds the term of the refunding bonds shall not exceed the term of the Prior Bonds refunded and the debt service on the refunding bonds does not exceed the debt service of the Prior Bonds refunded.

The Bonds shall bear interest from the date of delivery until the principal amount of the Bonds is paid, such interest (computed upon the basis of a 360-day year of twelve 30-day months) being payable semiannually on June 1 and December 1 of each year commencing on such date as identified in the Bond Order upon the advice of the municipal advisor.

Interest on the Bonds shall be payable from the interest payment date to which interest has been paid next preceding the authentication date of the Bonds unless the Bonds are authenticated after the fifteenth day preceding interest payment date and on or before such interest payment date in which case they shall bear interest from such interest payment date, or unless the Bonds are authenticated on or before the fifteenth day preceding the first interest

payment date, in which case they shall bear interest from the original date until the principal shall be fully paid.

The exact maturity schedule and interest rates shall be set forth in a bond order executed by the Board President following the sale of the Bonds (the “Bond Order”).

Section 3. Registrar and Paying Agent. The President of the Board shall name the Treasurer of the District or a bank with an office in Illinois to serve as Registrar and Paying Agent for the Bonds (the “Registrar” or “Paying Agent”) in the Bond Order. The Registrar is hereby charged with the responsibility of authenticating the Bonds. The principal of the Bonds shall be payable at the principal office of the Paying Agent. All payments of interest on the Bonds shall be paid by check, mailed one business day prior to the interest payment date to the registered owners thereof as the names appear as of the first day of the month containing the interest payment date and at the addresses as they appear on the registration books kept by the Registrar or at such other address as is provided to the Paying Agent in writing by such registered owner. If payment of principal or interest is made to a depository, payment shall be made by wire transfer on the payment date in same-day funds. If the payment date occurs on a date when financial institutions are not open for business, the wire transfer shall be made on the next succeeding business day. The Paying Agent shall be instructed to wire transfer payments by 1:00 p.m. (New York City time) so such payments are received at the depository by 2:30 p.m. (New York City time). All payments on the Bonds shall be made in any coin or currency of the United States of America, which on the date of such payment, shall be legal tender for the payment of public and private debts.

Each Bond shall be transferable or exchangeable only upon the books of the District kept for that purpose at the principal office of the Registrar by the registered owner in person, or by

its attorney duly authorized in writing, upon surrender of such Bond together with a written instrument of transfer or exchange satisfactory to the Registrar duly executed by the registered owner, or its attorney duly authorized in writing, and thereupon a new fully registered Bond or Bonds in an authorized aggregate principal amount and of the same maturity, shall be executed and delivered in the name of the transferee or transferees or the registered owner, as the case may be, in exchange therefor. The Registrar shall not be required to transfer or exchange any Bond during the period beginning at the close of business on the fifteenth (15th) day preceding any interest payment date on such Bond occurs and ending on such interest payment date. The costs of such transfer or exchange shall be borne by the District except for any tax or governmental charge required to be paid with respect to the transfer or exchange, which taxes or governmental charges are payable by the person requesting such transfer or exchange. The District, Registrar and Paying Agent for the Bonds may treat and consider the person in whose name such Bonds are registered as the absolute owner thereof for all purposes including for the purpose of receiving payment of, or on account of, the principal thereof and interest due thereon.

The Registrar and Paying Agent may at any time resign as Registrar and Paying Agent upon giving 30 days' notice in writing to the District and by first class mail to each registered owner of the Bonds then outstanding, and such resignation will take effect at the end of such 30 day period or upon the earlier appointment of a successor registrar and paying agent by the District. Any such notice to the District may be served personally or sent by registered mail. The Registrar and Paying Agent may be removed at any time as Registrar and Paying Agent by the District, in which event the District may appoint a successor registrar and paying agent. The District shall notify each registered owner of the Bonds then outstanding by first class mail of the removal of the Registrar and Paying Agent. Notices to the registered owners of the Bonds shall

be deemed to be given when mailed by first class mail to the addresses of such registered owners as they appear on the registration books kept by the Registrar.

Upon the appointment of any successor registrar and paying agent by the District, the Board President and Secretary are authorized and directed to enter into such agreements and understandings with such successor registrar and paying agent as will enable the institution to perform the services required of a registrar and paying agent for the Bonds. The Board President and Secretary are further authorized to pay such fees as the successor registrar and paying agent may charge for the services it provides as registrar and paying agent and such fees may be paid from the fund established to pay the principal of interest on the Bonds as fiscal agency charges.

Any predecessor registrar and paying agent shall deliver all of the Bonds and any cash or investments in its possession with respect thereto, together with the registration books, to the successor registrar and paying agent.

The District has determined that it is beneficial to the District to have the Bonds held by a central depository system pursuant to an agreement between the District and The Depository Trust Company, New York, New York (the "Depository Trust Company") and have transfers of the Bonds effected by book-entry on the books of the central depository system ("Book Entry System"). The Bonds shall be initially issued in the form of a separate single authenticated fully registered Bond for the aggregate principal amount of each separate maturity of the Bonds. Upon initial issuance, the ownership of such Bonds shall be registered in the register kept by the Registrar in the name of CEDE & CO., as nominee of the Depository Trust Company.

With respect to the Bonds registered in the register kept by the Registrar in the name of CEDE & CO., as nominee of the Depository Trust Company, the District and the Paying Agent shall have no responsibility or obligation to any other holders or owners (including any

beneficial owner (the “Beneficial Owner”)) of the Bonds with respect to (i) the accuracy of the records of the Depository Trust Company, CEDE & CO., or any Beneficial Owner with respect to ownership questions, (ii) the delivery to any bondholder (including any Beneficial Owner) or any other person, other than the Depository Trust Company, of any notice with respect to the Bonds including any notice of redemption, or (iii) the payment to any bondholder (including any Beneficial Owner) or any other person, other than the Depository Trust Company, of any amount with respect to the principal of, or premium, if any, or interest on the Bonds except as otherwise provided herein.

So long as the Bonds are registered in the name of CEDE & CO., as nominee of the Depository Trust Company, no person other than the Depository Trust Company shall receive an authenticated Bond evidencing an obligation of the District to make payments of the principal of and premium, if any, and interest on the Bonds pursuant to this ordinance. The District and the Registrar and Paying Agent may treat as and deem the Depository Trust Company or CEDE & CO. to be the absolute bondholder of each of the Bonds for the purpose of (i) payment of the principal of and premium, if any, and interest on such Bonds; (ii) giving notices of redemption and other notices permitted to be given to bondholders with respect to such Bonds; (iii) registering transfers with respect to such Bonds; (iv) obtaining any consent or other action required or permitted to be taken of or by bondholders; (v) voting; and (vi) for all other purposes whatsoever. The Paying Agent shall pay all principal of and premium, if any, and interest on the Bonds only to or upon the order of the Depository Trust Company, and all such payments shall be valid and effective fully to satisfy and discharge the District's and the Paying Agent's obligations with respect to principal of and premium, if any, and interest on the Bonds to the extent of the sum or sums so paid. Upon delivery by the Depository Trust Company to the

District of written notice to the effect that the Depository Trust Company has determined to substitute a new nominee in place of CEDE & CO., and subject to the provisions herein with respect to consents, the words “CEDE & CO.” in this ordinance shall refer to such new nominee of the Depository Trust Company. Notwithstanding any other provision hereof to the contrary, so long as any Bond is registered in the name of CEDE & CO., as nominee of the Depository Trust Company, all payments with respect to the principal of and premium, if any, and interest on such Bonds and all notices with respect to such Bonds shall be made and given, respectively, to the Depository Trust Company as provided in a representation letter from the District to the Depository Trust Company (the “Blanket Issuer Letter of Representations”).

Upon receipt by the District of written notice from the Depository Trust Company to the effect that the Depository Trust Company is unable or unwilling to discharge its responsibilities and no substitute depository willing to undertake the functions of the Depository Trust Company hereunder can be found which is willing and able to undertake such functions upon reasonable and customary terms, then the Bonds shall no longer be restricted to being registered in the register of the District kept by the Registrar in the name of CEDE & CO., as nominee of the Depository Trust Company, but may be registered in whatever name or names the bondholders transferring or exchanging the Bonds shall designate, in accordance with the provisions of this ordinance.

If the District determines that it is in the best interest of the bondholders that they be able to obtain certificates for the fully registered Bonds, the District may notify the Depository Trust Company and the Registrar, whereupon the Depository Trust Company will notify the Beneficial Owners of the availability through the Depository Trust Company of certificates for the Bonds. In such event, the Registrar shall prepare, authenticate, transfer and exchange certificates for the

Bonds as requested by the Depository Trust Company and any Beneficial Owners in appropriate amounts, and whenever the Depository Trust Company requests the District and the Registrar to do so, the Registrar and the District will cooperate with the Depository Trust Company by taking appropriate action after reasonable notice to (i) make available one or more separate certificates evidencing the fully registered Bonds of any Beneficial Owner's Depository Trust Company account or (ii) arrange for another securities depository to maintain custody of certificates for and evidencing the Bonds.

If the Bonds shall no longer be restricted to being registered in the name of the Depository Trust Company, the Registrar shall cause said Bonds to be printed in blank in such number as the Registrar shall determine to be necessary or customary; provided, however, that the Registrar shall not be required to have such Bonds printed until it shall have received from the District indemnification for all costs and expenses associated with such printing

Section 4. Redemption. The Bonds will be subject to Optional Redemption and Mandatory Redemption as set forth in the Bond Order.

Unless waived by any holder of Bonds to be redeemed, notice of the call for any such redemption shall be given by the Bond Registrar on behalf of the District by mailing the redemption notice by first class mail at least thirty (30) days and not more than sixty (60) days prior to the date fixed for redemption to the registered owner of the Bond or Bonds to be redeemed at the address shown on the Bond Register or at such other address as is furnished in writing by such registered owner to the Bond Registrar, or be electronic notification through The Depository Trust Company in accordance with its operating rules upon five (5) days notice.

All notices of redemption shall state:

- (1) the redemption date,



- (2) the redemption price,
- (3) if less than all outstanding Bonds are to be redeemed, the identification (and, in the case of partial redemption, the respective principal amounts) of the Bonds to be redeemed,
- (4) that on the redemption date the redemption price will become due and payable upon each such Bond or portion thereof called for redemption, and that interest thereon shall cease to accrue from and after said date,
- (5) the place where such Bonds are to be surrendered for payment of the redemption price, which place of payment shall be a corporate trust office of the Bond Registrar, and
- (6) such other information then required by custom, practice or industry standard.

Prior to any redemption date, the District shall deposit with the Bond Registrar an amount of money sufficient to pay the redemption price of all the Bonds or portions of Bonds which are to be redeemed on that date.

Unless moneys sufficient to pay the redemption price of the Bonds to be redeemed shall have been received by the Bond Registrar prior to the giving of such notice of redemption, such notice may, at the option of the District, state that said redemption shall be conditioned upon the receipt of such moneys by the Bond Registrar on or prior to the date fixed for redemption. If such moneys are not received, such notice shall be of no force and effect, the District shall not redeem such Bonds, and the Bond Registrar shall give notice, in the same manner in which the notice of redemption was given, that such moneys were not so received and that such Bonds will not be redeemed.

Notice of redemption having been given as aforesaid, the Bonds or portions of Bonds so to be redeemed shall, on the redemption date, become due and payable at the redemption price therein specified, and from and after such date (unless the District shall default in the payment of the redemption price) such Bonds or portions of Bonds shall cease to bear interest. Upon surrender of such Bonds for redemption in accordance with said notice, such Bonds shall be paid by the Bond Registrar at the redemption price. Installments of interest due on or prior to the redemption date shall be payable as herein provided for payment of interest. Upon surrender for any partial redemption of any Bond, there shall be prepared for the registered holder a new Bond or Bonds of the same maturity in the amount of the unpaid principal.

If any Bond or portion of Bond called for redemption shall not be so paid upon surrender thereof for redemption, the principal shall, until paid, bear interest from the redemption date at the rate borne by the Bond or portion of Bond so called for redemption. All Bonds which have been redeemed shall be cancelled and destroyed by the Bond Registrar and shall not be reissued.

Section 5. Execution and Negotiability. Each of the Bonds shall be executed in the name of the District by the manual or facsimile signatures of the Board President and the Secretary, and the seal of the District shall be affixed, imprinted, engraved or otherwise reproduced thereon and countersigned by the manual or facsimile signature of the Board Treasurer; and these officials, by the execution of a Signature and No Litigation Certificate, shall adopt as and for their own proper signatures the facsimile signatures appearing on the Bonds. In case any officer whose signature or facsimile signature appears on the Bonds shall cease to be such officer before the delivery of the Bonds, the signature of such officer shall nevertheless be valid and sufficient for all purposes the same as if such officer had remained in office until such delivery.

The Bonds shall have all of the qualities and incidents of negotiable instruments under the laws of the State of Illinois, subject to the provisions for registration herein.

The Bonds shall also be authenticated by the manual signature of the Registrar, and no Bond shall be valid or become obligatory for any purpose until the certificate of authentication thereon has been so executed.

Section 6. Form of Bonds. The form and tenor of the Bonds shall be substantially as follows, all blanks to be filled in properly prior to delivery:

If the payment date occurs on a date when financial institutions are not open for business, the wire transfer shall be made on the next succeeding business day. The Paying Agent shall wire transfer payments by 1:00 p.m. (New York City time) so such payments are received at the depository by 2:30 p.m. (New York City time). All payments on the bond shall be made in any coin or currency of the United States of America, which on the dates of such payment, shall be legal tender for the payment of public and private debts.

This Bond is a general obligation of the District payable as to principal and interest from charges for services in the District and such other funds of the District lawfully available and annually appropriated for such purpose. In the event that the aforementioned revenue sources are insufficient to pay the principal and interest on this Bond, ad valorem taxes shall be levied against all taxable property within the District, without limitation as to rate or amount, all in accordance with the provisions of the Act. This Bond is negotiable, subject to registration provisions, pursuant to the laws of the State of Illinois.

This Bond is one of an authorized series of bonds of the District of like date, tenor and effect, except as to rates of interest and dates of maturity; aggregating [\$31,000,000] numbered consecutively from R-1 up; issued to refund certain of the District's outstanding debt obligations, and to pay certain costs of issuance and incidental expenses (the "Refunding"), all for the benefit of the inhabitants of the District, as approved by the Board of Park Commissioners of the District (the "Board"). This Bond is issued pursuant to a Bond Ordinance adopted by the Board on the August 27, 2019 (the "Ordinance"), and in accordance with the Act, the proceeds of which bonds are to be applied solely to pay the cost of the Refunding [and the costs of issuance incidental thereto].

The Bonds are subject to Optional Redemption and Mandatory Redemption as set forth in the Bond Order executed by the Board President.

This Bond is transferable or exchangeable only upon the books of the District kept for that purpose at the principal office of the Registrar by the registered owner hereof in person, or by its attorney duly authorized in writing, upon surrender of this bond together with a written instrument of transfer or exchange satisfactory to the Registrar duly executed by the registered owner, or its attorney duly authorized in writing, and thereupon a new fully registered bond or bonds in an authorized aggregate principal amount and of the same maturity, shall be executed and delivered in the name of the transferee or transferees or to the registered owner, as the case may be, in exchange therefor. The Registrar shall not be required to transfer or exchange this bond during the period beginning at the close of business on the fifteenth (15th) day of the month preceding the interest payment date on this bond occurs and ending on such interest payment date. The District, the Registrar, the Paying Agent and any other registrar or paying agent for this bond may treat and consider the person in whose name this bond is registered as the absolute owner hereof for all purposes including for the purpose of receiving payment of, or on account of, the principal hereof and interest due hereon.

The Bonds shall be initially issued in a Book Entry System (as defined in the Ordinance). The provisions of this bond and of the Ordinance are subject in all respects to the provisions of

the Blanket Issuer Letter of Representations (as defined in the Ordinance) between the District and The Depository Trust Company, or any substitute agreement, effecting such Book Entry System.

This Bond is subject to defeasance prior to payment as provided in the Ordinance referred to herein. THE OWNER OF THIS BOND, BY THE ACCEPTANCE HEREOF, HEREBY AGREES TO ALL THE TERMS AND PROVISIONS CONTAINED IN THE ORDINANCE.

The Bonds maturing in any one year are issuable only in fully registered form in the denomination of \$5,000 or any integral multiple thereof.

It is hereby certified and recited that all acts, conditions and things required to be done precedent to and in the execution, issuance and delivery of this bond have been done and performed in regular and due form as provided by law; that the indebtedness of the District, including the issue of the Bond of which this is one, does not exceed any limitation imposed by law; and that provision has been made for the collection of alternate revenues sufficient to pay the interest hereon as it falls due and also to pay and discharge the principal hereof at maturity.

This Bond shall not be valid or become obligatory for any purpose until the certificate of authentication hereon shall have been executed by an authorized representative of the Registrar.

Section 7. Sale of Bonds. The final terms for each series of the Bonds issued to refund Prior Bonds will be based on the economic savings satisfactory to the District. The economic savings will be based on current market conditions and the District's financial advisor and District administration will provide support for satisfactory savings. The authorization to approve each Bond Sale is delegated to the Board President and the Secretary although they are free to consult with the other members of the Board individually before acting. In connection with this delegation, the following are the additional details that the Board President and Secretary will also approve to facilitate the sale of the Bonds that are referenced within this ordinance:

Prior Bonds to be Refunded

Paying Agent

Maturities and coupons not to exceed 5%

Redemption provisions both Optional and Mandatory

Type of obligation including forward delivery commitment to purchase bonds, convertible bonds, advanced refunding bonds, and current refunding bonds

Format for sale including negotiated underwriting, competitive sale, private placement or direct placement.

Escrow accounts.

Purchaser

Authorization of other costs including funding from available funds of the District based on the terms of the sale.

Other terms, covenants and conditions that enable the sale of the bonds.

The above terms will be incorporated in the Bond Order to be executed by the Board President and Secretary and are thereby incorporated into this Ordinance. The Bond Order shall be entered into the records of the District and made available to the Board of Commissioners at the next regular meeting thereof; but such action shall be for information purposes only, and the Board of Commissioners shall have no right or authority at such time to approve or reject such sale as evidenced in the Bond Order. The District Treasurer is hereby authorized to proceed to deliver each series of Bonds to the respective purchaser thereof (each, a "Purchaser") identified in the Bond Order, upon receipt of the principal amount of thereof plus a premium or less a discount as set forth in the Bond Order. Each series of Bonds may be sold through either a competitive or negotiated sale at the discretion of the District's financial advisor necessary to achieve the best economic result for the District. The Board President and the Secretary are authorized and directed to execute a bond purchase agreement, or other such similar agreement relating to the sale and delivery of such refunding bonds (the "Purchase Contract"), in connection with the sale of each series of Bonds, in the name of and on behalf of the District. The Purchase Contract shall be substantially in the form of purchase contracts commonly used in transactions similar to that described in the Ordinance, and may be a forward purchase, direct placement agreement or other similar arrangement for the sale and delivery of refunding bonds, with such changes as necessary to reflect the terms and provisions of each series of Bonds, this Ordinance and such other changes as the President or Treasurer shall determine are necessary or desirable in connection with the sale of each series of Bonds. No person holding any office of the District, either by election or appointment, is in any manner financially interested directly in his own name or indirectly in the name of any other person, association, trust or corporation, in the Purchase Contract. The President is authorized to approve the form of the Preliminary

Official Statement for each Bonds and to deem it nearly final, and the President is hereby authorized and directed to execute the final Official Statement after the sale of each series of Bonds to applicable the Purchaser. The President is authorized to approve the form of the Continuing Disclosure Undertaking, and the President and Secretary are authorized and directed to complete and execute the Continuing Disclosure Undertaking with such changes as they deem necessary or appropriate. The President and Secretary are also authorized and directed to apply for and obtain municipal bond insurance on each series of Bonds if the Purchaser can demonstrate that the present value of the interest to be saved by procuring such insurance is greater than the premium required to be paid to procure it. The President and Secretary are also authorized to execute an Escrow Agreement, or similar agreement, in connection with the Refunding.

Section 8. Alternate Revenue Source; Additional Security Tax Levy. For the purpose of providing funds required to pay the interest on the Bonds promptly when and as the same falls due, and to pay and discharge the principal thereof at maturity, the District covenants and agrees with the Purchaser and the owners of the Bonds that the District will deposit the Pledged Revenues. The Pledged Revenues are hereby pledged to the payment of the Bonds, and the Board covenants and agrees to provide for, collect and apply the Pledged Revenues to the payment of the Bonds. The Board covenants, to the extent it is empowered to do so, to provide for, collect and apply such Pledged Revenues, as applicable, to the payment of the Bonds, the 2010A Bonds, the 2010B Bonds, the 2013A Bonds and the 2014A Bonds, and the provision of not less than an additional 0.25 times debt service

For the purpose of providing additional security to guarantee funds sufficient to pay interest on the Bonds as it falls due and pay and discharge the principal thereof at maturity, if the



above-mentioned Pledged Revenues are insufficient to pay said alternate bonds, there be and there is hereby levied upon all the taxable property within the District a direct annual tax (the “Pledged Taxes”) for each of the years while the Bonds or any of them are outstanding, in amounts sufficient for that purpose, and that there be and there is hereby levied upon all of the taxable property in the District, in addition to all other taxes, a direct annual tax in the years and amounts as set forth in the Bond Order.

Principal or interest coming due at any time when there are not sufficient funds on hand from the Pledged Revenues to pay the same shall be paid from current funds on hand of the District, and the fund from which such payment was made shall be reimbursed out of the Pledged Taxes hereby levied when the same shall be collected.

The District covenants and agrees with the Purchaser and the owners of the Bonds that so long as any of the Bonds remain outstanding, the District will take no action or fail to take any action which in any way would adversely affect the ability of the District to collect the Pledged Revenues or to levy and collect the Pledged Taxes, and the District and its officers will comply with all present and future applicable laws in order to assure that the Pledged Revenues will be available and that the Pledged Taxes will be levied, extended and collected as provided herein and deposited in the Bond Fund.

The funds derived from the tax levy when Pledged Revenues are insufficient are hereby appropriated and set aside for the sole and only purpose of paying principal and interest on said Bonds when and as the same become due.

Section 9. Filing of Ordinance – Bond Fund. After this Ordinance becomes effective, a copy hereof, certified by the Secretary, shall be filed with the County Clerk of Cook County (the “County Clerk”). The County Clerk shall, in years when the Pledged Revenues are

insufficient to pay the principal and interest due on the Bonds, ascertain the rate required to produce the aggregate Pledged Taxes hereinbefore provided to be levied in each of said years; and the County Clerk shall extend the same for collection on the tax books in connection with other taxes levied in said years in and by the District for general corporate purposes of the District; and the County Clerk, or other appropriate officer or designee, shall remit the Pledged Taxes for deposit to the credit of a special fund created by Section 9 hereof and referred to as the “Bond Fund”, and in said years the Pledged Taxes shall be levied and collected by and for and on behalf of the District in like manner as taxes for general corporate purposes of the District for said years are levied and collected, and in addition to and in excess of all other taxes. The Pledged Taxes are hereby irrevocably pledged to and shall be used only for the purpose of paying principal of and interest on the Bonds. The Board, by ordinance, may, prior to the time the Pledged Taxes levied in such calendar year are extended, direct the abatement of the Pledged Taxes, and proper notification of such abatement shall be filed with the County Clerk in a timely manner to effect such abatement based on the anticipation that there will be adequate Pledged Revenues available to pay the debt service that would have been paid by Pledged Taxes. The District can also provide other funds for the repayment of the Bonds.

Section 10. Bond Fund and Escrow Fund. (a) Bond Fund. There is hereby established a special fund of the District known as the “Alternate Bond and Interest Fund of 20\_\_ (with each year designated as appropriate)” (the “Bond Fund”) to be held by the Paying Agent which is a trust fund established for the purpose of carrying out the covenants, terms and conditions imposed upon the District by this ordinance. The Bonds are secured by a pledge of all of the moneys on deposit in the Bond Fund, and such pledge is irrevocable until the Bonds have been paid in full or until the obligations of the District are discharged under this ordinance. The

Bond Fund shall only be used to pay the interest on the Bonds and principal of the Bonds at maturity or upon redemption. Pledged Revenues, and Pledged Taxes when required, shall be collected and deposited into the Bond Fund as set forth herein.

(b) Escrow Fund. There is hereby established a special fund of the District known as the “Escrow Fund” to be held by the Treasurer. There shall be deposited in the Escrow Fund the proceeds of the Bonds in an amount sufficient to effect the Refunding. The Escrow Fund shall be maintained separate and apart from all other accounts of the District. Moneys in the Escrow Account shall be used to complete the Refunding.

Section 11. Use of Bond Proceeds. Proceeds of the Bonds in an amount sufficient to effect the Refunding and costs associated therewith are hereby appropriated for paying the costs of the Refunding and are hereby ordered deposited into the Escrow Fund. Any Bond proceeds received to pay the costs of issuance shall be deposited with the District to pay for such costs. The balance of any Bond proceeds received in excess of amounts required to effect the Refunding and pay all necessary and incidental costs related thereto on the delivery of the Bonds is hereby appropriated for the purpose of paying interest due on the Bonds and is hereby ordered deposited into the Bond Fund.

Interest received from deposits in the Escrow Fund shall, at the discretion of the Board, either be transferred for the payment of the principal of and interest on the Bonds on the interest payment date next after such interest is received or retained in the Escrow Fund. In the event that any moneys remain in the Escrow Fund upon completion of the Refunding, the District shall deposit the remaining moneys into the Bond Fund. Such moneys which are on deposit in the Bond Fund after 30 days of the date of deposit shall be invested at a yield not exceeding the yield

on the Bonds in the event that the investment of such moneys shall cause the Bond Fund not to be a bona fide debt service fund pursuant to Treas. Reg. Section 1.148(1)(b).

Section 12. Defeasance of the Bonds. If, when the Bonds or a portion thereof shall have become due and payable in accordance with their terms, and the whole amount of the principal and the interest and the premium, if any, so due and payable upon all of the Bonds or a portion thereof then outstanding shall be paid; or (i) sufficient moneys or (ii) direct obligations of the United States of America (including obligations issued or held in book entry form on the books of the Department of the Treasury), the principal of and the interest on which when due will provide sufficient moneys for such purpose, shall be held in trust for such purpose, and provision shall also be made for paying all fees and expenses for the redemption, then and in that case the Bonds or any designated portion thereof issued hereunder shall no longer be deemed outstanding or entitled to any pledge of the Pledged Revenues and/or the Pledged Taxes made herein.

Section 13. Investment of Moneys. Moneys in the Bond Fund and the Escrow Fund may be invested by the Treasurer in lawful investments for the District. All income earned or losses sustained on such investments shall be credited to the Fund or Account from which the investments were made.

Section 14. Additional Bonds. The District may without limit issue additional bonds (“Additional Bonds”) on a parity with or junior to the Bonds as to the pledge of the Pledged Revenues. If such Additional Bonds are to be parity bonds, the Pledged Revenues shall be sufficient to provide for or pay all of the following: (i) debt service on all outstanding Bonds computed immediately after the issuance of any proposed Additional Bonds, and (ii) an additional amount not less than 0.25 times debt service on the outstanding Bonds and Additional

Bonds after the issuance of the proposed Additional Bonds. Such sufficiency shall be calculated for each year to the final maturity of the Bonds and the Additional Bonds. The determination of the sufficiency of the Pledged Revenues shall be supported by reference to the most recent audit of the District, which audit shall be for a Fiscal Year ending not earlier than eighteen (18) months previous to the time of issuance of the proposed Additional Bonds. If such audit shows the Pledged Revenues to be insufficient, then the determination of sufficiency may be supported by the report of an independent accountant or feasibility analyst demonstrating the sufficiency of the Pledged Revenues and explaining by what means they will be greater than shown in the audit.

Section 15. Amendments with Consent of Bondholders. Subject to the terms and provisions contained in this section, and not otherwise, the owners of not less than one hundred percent (100%) in aggregate principal amount of the Bonds issued pursuant to this ordinance and then outstanding shall have the right from time to time, anything contained in this ordinance to the contrary notwithstanding, to consent to and approve the adoption by the District of such ordinance or ordinances supplemental hereto or amendatory hereof, as shall be deemed necessary or desirable by the District for the purpose of modifying, altering, amending, adding to or rescinding in any particular manner any of the terms or provisions contained in this ordinance, or in any supplemental ordinance; provided, however, that nothing herein contained shall permit or be construed as permitting.

(a) An extension of the maturity of the principal of or interest on any Bond issued pursuant to this ordinance; or

(b) A reduction in the principal amount of any Bond or the rate of interest thereon; or

(c) A preference or priority of any Bond or Bonds issued pursuant to this ordinance over any other Bond or Bonds issued pursuant to the provisions of this ordinance; or

(d) A reduction in the aggregate principal amount of the Bonds required for consent to such supplemental ordinance; or

If the owners of not less than one hundred percent (100%) in aggregate principal amount of the Bonds outstanding at the time of adoption of such supplemental ordinance shall have consented to and approved the adoption thereof by written instrument to be maintained on file in the office of the Board Secretary of the District, no owner of any Bond issued pursuant to this ordinance shall have any right to object to the adoption of such supplemental ordinance or to object to any of the terms and provisions contained therein or the operation thereof, or in any manner to question the propriety of the adoption thereof, or to enjoin or restrain the District from adopting the same, or from taking any action pursuant to the provisions thereof. Upon the adoption of any supplemental ordinance pursuant to the provisions of this section, this ordinance shall be, and shall be deemed, modified and amended in accordance therewith, and the respective rights, duties and obligations under this ordinance of the District and all owners of Bonds then outstanding, shall thereafter be determined, exercised and enforced in accordance with this ordinance, subject in all respects to such modifications and amendments. Notwithstanding anything contained in the foregoing provisions of this ordinance, the rights and obligations of the District and of the owners of the Bonds authorized by this ordinance, and the terms and provisions of the Bonds and this ordinance, or any supplemental or amendatory ordinance, may be modified or altered in any respect with the consent of the District and the consent of the owners of all the Bonds then outstanding.

Section 16. Tax Covenants. In order to preserve the exclusion of interest on any series of Bonds designated as tax-exempt or tax-advantaged (the “Tax Advantaged Bonds”) from gross income for federal tax purposes under Section 103 of the Internal Revenue Code of 1986 as existing on the date of issuance of the Tax Advantaged Bonds and the Regulations in effect and applicable to the Bonds on the date of issuance of the Tax Advantaged Bonds (collectively, the “Code”), and as an inducement to purchasers of the Tax Advantaged Bonds, the District represents, covenants and agrees that:

(a) No person or entity other than the District or another state or local governmental unit will use more than 10% of the proceeds of the refunded bonds or property financed by the refunded bond proceeds other than as a member of the general public. No person or entity other than the District or another state or local governmental unit will own property financed by refunded bond proceeds or will have any actual or beneficial use of such property pursuant to a lease, a management or incentive payment contract, arrangements such as take-or-pay or output contracts or any other type of arrangements that conveys other special legal entitlements and differentiates that person’s or entity’s use of such property from use by the general public, unless such uses in the aggregate relate to no more than 10% of the proceeds of the refunded bonds. If the District enters into a management contract for park property, the terms of the contract will comply with IRS Revenue Procedure 2017-13, as it may be amended, supplemented or superseded from time to time, so that the contract will not give rise to private business use under the Code, unless such use in aggregate relates to no more than 10% of the proceeds of the Tax Advantaged Bonds.

(b) No more than 5% of the Tax Advantaged Bond proceeds will be loaned to any entity or person other than a state or local governmental unit. No more than 5% of the Tax

Advantaged Bond proceeds will be transferred, directly or indirectly, or deemed transferred to a nongovernmental person in any manner that would in substance constitute a loan of the Tax Advantaged Bond proceeds.

(c) The District reasonably expects, as of the date hereof, that the Tax Advantaged Bonds will not meet either the private business use test described in paragraph (a) above or the private loan test described in paragraph (b) above during the entire term of the Tax Advantaged Bonds.

(d) No more than 5% of the proceeds of the Tax Advantaged Bonds will be attributable to private business use as described in (a) or attributable to unrelated or disproportionate private business use. For this purpose, the private business use test is applied by taking into account only use that is not related to any governmental use of proceeds of the issue (Unrelated Use) and use that is related but disproportionate to any governmental use of those proceeds (Disproportionate Use).

(e) Neither the District nor the Board will take any action or fail to take any action with respect to the Bonds that would result in the loss of the exclusion from gross income for federal tax purposes on the Tax Advantaged Bonds pursuant to Section 103 of the Code as applicable, nor will the District or the Board act in any other manner which would adversely affect such exclusion.

(f) It shall not be an event of default under this ordinance if the interest on any Tax Advantaged Bond is not excludable from gross income for federal tax purposes or otherwise pursuant to any provision of the Code which is not currently in effect and in existence on the date of issuance of the Tax Advantaged Bonds.



(g) These covenants are based solely on current law in effect and in existence of the date of delivery of the Tax Advantaged Bonds.

The Board hereby authorizes the officials of the District responsible for issuing the Tax Advantaged Bonds, the same being the President, the Secretary and the Treasurer of the Board, to make such further covenants and certifications as may be necessary to assure that the use thereof will not cause the Tax Advantaged Bonds to be arbitrage bonds and to assure that the interest on the Tax Advantaged Bonds will not lose the exclusion from gross income for federal income tax purposes. In connection therewith, the District further agrees: (a) through its officers, to make such further specific covenants, representations as shall be truthful, and assurances as may be necessary or advisable; (b) to consult with counsel approving the Tax Advantaged Bonds; (c) to pay to the United States, as necessary, such sums of money representing required rebates of excess arbitrage profits relating to the Tax Advantaged Bonds as required pursuant to Section 148 of the Code and the regulations promulgated thereunder; (d) to file such forms, statements, and supporting documents as may be required and in a timely manner; and (e) if deemed necessary or advisable by their officers, to employ and pay fiscal agents, financial advisors, attorneys, and other persons to assist the District in such compliance.

The Board is further authorized to make any designations or other elections pursuant to the Code or corresponding regulations necessary with respect to the Tax Advantaged Bonds as necessary upon the advice of its municipal advisor and its bond counsel in each applicable Bond Order.

Section 17. Noncompliance with Tax Covenants. Notwithstanding any other provisions of this ordinance, the covenants and authorizations contained in this ordinance (the “Tax Sections”) which are designed to preserve the exclusion of interest on the Tax Advantaged

Bonds from gross income under federal law (the “Tax Exemption”), need not be complied with if the District receives an opinion of nationally recognized bond counsel that any Tax Section is unnecessary to preserve the Tax Exemption.

Section 18. Registered Form. The District recognizes that Section 149(a) of the Code requires the Tax Advantaged Bonds to be issued and to remain in fully registered form in order that interest thereon is exempt from federal income taxation under laws in force at the time the Tax Advantaged Bonds are delivered. In this connection, the District agrees that it will not take any action to permit the Tax Advantaged Bonds to be issued in, or converted into, bearer or coupon form.

Section 19. Professional Services. The District shall retain Austin Meade Financial Ltd. to serve as financial advisor and Taft Stettinius & Hollister LLP to serve as bond counsel in connection with the issuance of the Bonds.

Section 20. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section 21. Publication. The Board Secretary is hereby authorized and directed to publish this ordinance in pamphlet form and to file copies thereof for public inspection in his/her office.

Section 22. Conflicting Ordinances. All ordinances, resolutions and parts of ordinances and resolutions, in conflict herewith are hereby repealed. This Ordinance amends and restates in its entirety Ordinance O19-003.

Section 23. Headings. The headings or titles of the several sections shall be solely for convenience of reference and shall not affect the meaning, construction or effect of this ordinance.

Section 24. Effective Date. This ordinance shall be in full force and effect from and after its adoption and approval.

**Background**

The Northwest Special Recreation Association (NWSRA) which provides programing for children and adults with disabilities in our community has approved the 2020 Member District Annual Assessments (MDAA). These are computed using a formula approved by the NWSRA board (which Executive Director Talsma is a member).

**Implications**

The Actual Member District Annual Assessment (MDAA) for 2019 used the EAV numbers from each Member District's 2018 EAVs and current audited gross population numbers which resulted in a 1% decrease from the previous fiscal year. This was calculated using the formula of 75% EAV and 25% Gross Population formula with a 2% ceiling/floor. However, NWSRA is proposing a 1% increase for the 2020 MDAA due to the minimum wage impact. In 2019, the District Assessment was \$306,658.80.

**Recommendation**

Staff recommends that the A&F Committee recommends that the board approve the NWSRA Assessment Resolution No. R19-004 ratifying the assessment for calendar year 2020 in the amount of \$307,467.90 as recommended by the Board of Trustees of NWSRA.
