Groups and organizations are required to complete the Park Shelter Rental Application and provide a certificate of insurance issued specifically for this rental in accordance with the Hoffman Estates Park District Certificate of Insurance Requirements.

I, the undersigned, hereby certify that I am / we are the sponsor(s) or appointed representative(s) of the organization requesting use of the field / park. I hereby expressly agree individually and on behalf of said organization(s) to indemnify and forever hold harmless the Hoffman Estates Park District as to any claim or claims which arise out of the use of the field/ park. In addition, I assume the following responsibilities:

- 1. Only that part of the park for which the request is made shall be used.
- 2. If the activity involves children, ample adult supervision will be in attendance for the entire time of the activity: one (1) adult for every fifteen (15) children.
- 3. Proper care will be given to the premises, with garbage and other left over materials deposited in the appropriate receptacles provided.
- 4. Native landscape including trees, shrubs, pants, grass, etc. shall not be cut, trimmed, removed or destroyed.
