# 6. New Business:

# A. Administration & Finance Board Report and 1st Quarter Goals / M24-037

Comm Rep Wilson made a motion, seconded by Comm Rep Winner to recommend the April Administration & Finance Report and 1<sup>st</sup> Quarter Goals be included in the April Executive Director's Report.

Comm Rep Winner asked about the use of GIS data from Cook County to verify tax rolls. Director Hopkins said the intention is to make sure we are not missing any properties that would be on the tax roll, including new properties.

Commissioner McGinn asked about the goal to give residents the ability to rent park shelters online. Director Hopkins said this is the goal but is not fully ready. It worked well with cabana rentals at Seascape last summer. Parks and gazebos are a little more involved but should be ready to go soon. Executive Director Talsma added that the gazebos at our splash pads (e.g., South Ridge) are not available to rent when the splash pad is open.

#### B. Open and Paid Invoice Register: \$1,073,965.43:

Comm Rep Wilson made a motion, seconded by Comm Rep Harner to recommend the Board approve the Open and Paid Invoice Register as presented.

# C. <u>District Wide Operations Statement, Revenue and Expenditure Report and Financial Statement Analysis:</u>

Comm Rep Wilson made a motion, seconded by Comm Rep Harner to recommend the Board approve the District Wide Operations Statement, Revenue and Expenditure Report, and Financial Statement Analysis as presented.

Director Hopkins commented on a question from last month, regarding leagues being slightly lower than last year. The basketball leagues lost nineteen players due to the Hoffman Feeder League opening up teams for 3<sup>rd</sup> and 4<sup>th</sup> grade boys and girls.

Commissioner McGinn asked what the Smart Rain Irrigation System is that went into three parks. Executive Director Talsma said this is a feature that connects to the irrigation system, keeping it from turning on if it is raining.

Comm Rep Winner asked what we water at Victoria Park. Executive Director Talsma said it is most likely the soccer field.

The motion carried by voice vote.

# 7. Committee Member Comments:

Comm Rep Harner wanted to congratulate Executive Director Talsma for receiving the Honored Professional Award. He was pleased to see we are in the top five districts in using non-tax revenue to cover expenses.
